Project Status

Asset Management – Traditional Asset Management

No new updates. I've reached out to Dave Fox from Raftelis suggesting he present his revisions based on our first meeting at the Commission meeting on 4/10. We could then have any final recommendations/revisions for Raftelis and plan for an evening public hearing on 4/24 with the goal of ample public notice before the rates increase for the July billing.

We have received the draft scope from Black & Veatch. I am reviewing the scope and will be meeting with B&V soon to discuss.

Saco River Erosion

Last Friday, I met with NHDES Wetlands Bureau staff to tour our side of the Saco at the WWTF. We had good conversation about the project need, and specifically why the Precinct had chosen to move forward with the full river re-meander option rather than just armoring the existing banks. I do think there may be some challenges we need to work through with respect to wetlands impacts, but I'm

confident that we are doing this project for the right reasons and that our design team will work to minimize impacts and perhaps even enhance wetlands habitat in the process.

WWTF Aeration Upgrades

Staff met with Wright-Pierce onsite last week to review the 90% drawings. We are in a good place and confident that we'll have the final bid package ready to bid this spring.

Sewer Department – New Hire

We have posted the job for wastewater operator in-house after reaching agreement with the Union on a couple of issues. If no one in-house applies, the job will then be posted externally with a hire date of April 1, after the new budgets get approved at Annual Meeting.

Motion of Commissioner Umberger and seconded by Commissioner Fauver to sign the MOA between the North Conway Water Precinct and the State Employees Association of New Hampshire (SEIU), Local 1984.
